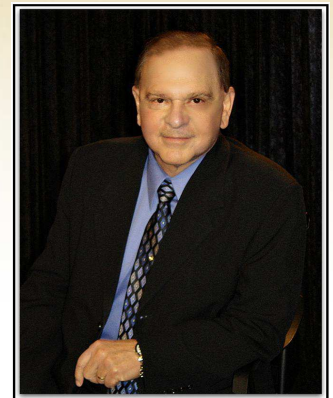

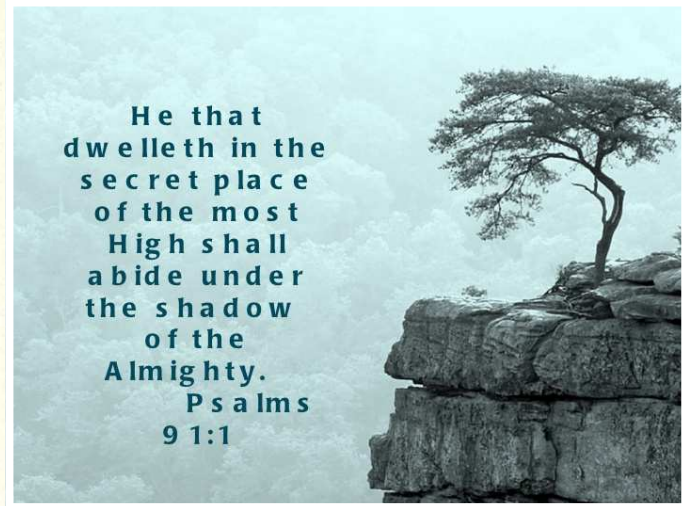
As a young man in my teens, I recall plowing the fields of my father's farm in the coastal plains of South Georgia. Around noon, when the scorching rays of the sun were at their highest point, the old mule and I would stop to rest under the shade (shadow) of a tree. What a time of refreshing! Nevertheless, my time *under the shadow* of the tree was short lived, because soon the afternoon sun began sinking lower in the west and it was impossible to find a shady refuge. What a picture! There's a lesson here to be learned, and it is this: "Refuge produced by earthly shadows are temporal, but God's shadow brings forth a refuge that will provide both temporal and eternal comfort." Thus, I learned in the fields of South Georgia what Solomon states as axiomatic in the Song of Solomon 2:3 "I sat down under his shadow with great delight, and his fruit was sweet to my taste." **Connect Impact with Budget**

It's easy to assume attitudes around generosity have led to [decreased giving]. But the truth is that today's church members are as just generous as in years past. The difference is this: there are more organizations competing for the attention and resources of your church member than ever before. Research also tells us that people are beginning to split their charitable giving. How do we overcome this challenge?

We must give people a compelling reason to support our ministry. We must find a way to communicate the connection between the budget and ministry impact. This takes work, but it also gives us the opportunity to identify the things that inspire people to give and ultimately generate more momentum for our ministry.

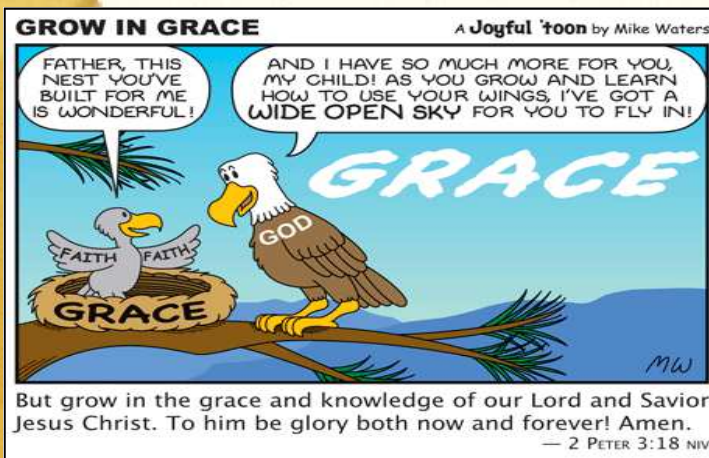

**Q:** *What happens if a minister requests a housing allowance that exceeds his total salary?*

We just hired a pastor, and he is purchasing a new home with a very large down payment. This will make the cost of his housing higher than his salary. How do we handle that?

**A:** A church can only allocate an allowance up to the minister's yearly salary—presuming the minister qualifies for an allowance based on IRS requirements, and the anticipated housing costs represent compensation for ministerial services, go exclusively toward paying housing expenses, and reflect fair rental value of the home (furnished, plus utilities). If a minister's housing expenses are higher than that, it's up to him or her to earn the difference elsewhere. If a minister does so, your church cannot designate more money for the allowance under the presumption that your minister will earn income from other jobs to make up the difference. Let's say your minister earns \$15,000 a year with your church, and he anticipates housing expenses of \$17,500 for 2017. He cannot earn an additional \$2,500 from working 10 hours a week at a coffee shop and have your church designate his housing allowance as \$17,500. And those additional funds will be taxed like any other payroll because those earnings are not affiliated with his ministerial work at the church.

## What is a Deductible Gift

We as Christians have a duty to help those in need. These needs can present themselves in a variety of ways, but one of the most common is the unexpectedly ill church member with rising medical bills. Is your generous monetary gift to aid this fellow Christian deductible?

In short, no. Only donations given to 501 (c)(3) entities without any expectation of control over the use of the funds are tax-deductible. You cannot simply give a donation to the church and ask them to pass it on to the needy member, as ultimately you still have control over the use of the donation and the funds are meant to benefit the individual, not the church.

There are certainly ways the church can set up a formal benevolence policy to aid church members and community members in need. Donations given to the benevolence fund can be tax-deductible as the church ultimately has control over who is aided by the donation. ### Tax Dates to Remember

#### April 15

- Federal Income tax and self-employment tax returns by individuals for calendar year 2015 are due by this date.
- Ministers who have not elected voluntary withholding and self-employed workers must file their first quarterly estimated federal tax payment for 2016 by this date.

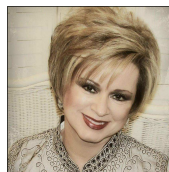
#### April 29

- Churches hiring their first non-minister employee between January 1 and March 31, 2016 may exempt themselves from the employer's share of FICA (Social Security) taxes by filing Form 8274 by this date.

#### April 30

- Churches having non-minister employees who report their federal incomes taxes as employees and who have elected voluntary withholding must file an employer's quarterly federal tax return (Form 941) for the first calendar quarter of 2016 by this date.

### IRS Announces 2017 Mileage Rates

- ◆ 53.5 cents per mile for business miles driven, down from 54 cents for 2016
- ◆ 17 cents per mile driven for medical or moving purposes, down from 19 cents for 2016
- ◆ 14 cents per mile driven in service of charitable organizations
