


God has brought back His

Warning For Us All: CALIFORNIA LEGISLATION ALERT!



As many of you in California are no doubt already aware, the California legislature is moving forward with a very troubling piece of legislation. AB 2943 would be added to the California Consumer Legal Remedies Act by illegalizing any "advertising, offering to engage in, or engaging in sexual orientation change efforts with an individual," if those activities are intended to result or do result in the sale or lease of goods or services to any consumer. The term "sexual orientation change efforts" is defined as any practices that seek to change an individual's sexual orientation, including efforts to "eliminate or reduce sexual or romantic attractions or feelings toward individuals of the same sex."

Sadly this is not California's first attempt to limit "change efforts." California already has laws in place making it illegal for any licensed therapists or counselors to engage directly in "change efforts" with clients. However, this new bill is even more concerning because of the vague language and potential breadth. AB 2943 would allegedly illegalize any sale of goods or services that supposedly had any relation to "change efforts." This could and likely would criminalize the sale of any Christian counseling books addressing dealing with homosexual persons in a Biblical way. The Assembly Judiciary Committee even acknowledged the law could encompass church retreats that charged money to attend. While unlikely, someone could even attempt to argue this law could ban the sale of Bibles.

Now is the time for Christians of California to speak up and let their voices be heard regarding this legislation. What can you do? (Christian Law Association)

Employing Ex-Offenders

A touchy subject at best but one the church is dealing with at a rapid pace due to the large number of persons incarcerated in the US. As Christians we cannot just pretend the problem does not exist. Is the church a place for ex-offenders to find a place of employment re-entry? Below are some thoughts from a recent article in Church Law & Tax Report by Richard Hammer. The statements are used with permission.

1. It is against the Equal Employment Act for a person to be denied employment solely on their criminal background the same as with gender, race, or age.

- When considering an ex-offender for a position do the following:

 A. Inquire. Ask them questions about their full histories and backgrounds.
 - B. Verify. Go to the courthouse and check public records to verify what they have disclosed. Answer the following questions: What were the charges? What were they convicted for? How long were they in prison? Did they disclose everything?
- 3. Document. Write those verified answers down. Keep a confidential personnel file for each candidate.
- 4. Repeat. Every so often, go through the preceding steps and run checks on every staff member, those with or without a prior criminal record, because statuses have the potential to change over time.

Along with the above steps check for rehabilitation efforts (such as anger management counseling) and call their references. The questions are: Are they truthful? Or are they hiding it? If they're hiding it, you should be more suspicious.

The church administration has the responsibility of the safety of the congregation. If a crime were to occur, the church may be sued for risk of negligent hiring. That phrase means the carelessness or failure to exercise reasonable care in the selection of a worker. Negligent selection claims arise any time that a church's failure to exercise reasonable care in the selection of an employee or volunteer leads to a foreseeable injury. (See Chapter 10, Volume 4 of Pastor, Church & Law, 4th edition by Richard Hammer.

One way to avoid negligence after hiring is not to select to place the exoffender in an area of service related to his offense. (i.e. don't put a sex offender in a children's or youth ministry). Provide mentoring and make sure the new hire is fully trained. Create accountability for all your employees.

There is hope for ex-offenders and the church has its part to play in this ministry of recovery. By doing extensive work on the front end and putting good markers into place along the way many be brought back to full productivity. And the church can have a hand in it. (Christian Law Association)

July 17th

1. If you have non-ministerial employees and deposit payroll taxes monthly, the June 2018 payroll tax deposit is due.

July 31st

1. File Form 941 (payroll tax) for the second quarter of 2018 and deposit any unpaid taxes. If your tax liability is less than \$2,500, you can pay it in full with a timely filed return. If you deposited the tax for the quarter timely, properly, and in full, you have until August 10th to file the return.
