The above is not a Christmas scripture but frankly this is a Christmas like no other. In praying over a "Christmas" newsletter, I kept coming back to the end of the above scripture, "lest you become weary and discouraged in your souls." I believe all of the saints of yesteryear have been praying that over us in 2020. My mind wandered to the type of world Mary brought Jesus into. The world around her looked very much like ours, the government was openly corrupt, the religious system of the time was tolerated, not celebrated, and people were allowed to practice their faith as long as they kept it in boundaries the government had implemented. There was widespread poverty and such a longing for the promised deliverer to come, but at the same time pronouncing what they thought he must look like and act like. Now on top of all Mary had gone through with the public shame some believed her guilty of, and the incomprehensible call of God on her life, Mary was being ordered to Bethlehem to make sure she was counted for tax purposes. The promise God gave her at conception did not give those details. Many times we can hear and understand the will of God but some of the details HE keeps to HIMSELF. That is where our faith comes in. We trust God when we cannot see clearly HIS will being performed. We have to remind ourselves that we at times see through a glass dimly to quote Paul. But we never surrender to the thought that God has been defeated or deterred in any avenue.

No matter what Christmas looks like for your family this year, let's make it about carrying the source of salvation to everyone we are with. There may not be money for gifts because many have lost jobs; there may be some empty chairs because some have lost family; there may be a smaller meal because supplies are limited, but there can be an abundance of love and hope. Not because of what is around us but because of what is in us.

## Taylor: We can act the part, look the part, but God sees the heart

The Bible says that God's ways are not our ways. It's often difficult to fully understand how God works and speaks because He is so far above His creation, man.

### Church/Ministry Tax to Remember

#### December 15, 2020

- Complete all year-end transactions to be sure that they are reportable on your income tax return.
- A church must make quarterly estimated tax payments if it expects an unrelated business income tax liability for the year to be \$500 or more. Use IRS Form 990-W to figure your estimated For 2020, quarterly estimated tax payments of onefourth of the total tax liability are due by April 15, June 15, September 15, and December 15, 2020, for churches on a calendaryear basis. Deposit quarterly tax payments electronically using EFTPS.

#### December 31, 2020

- Churches must designate a portion of each minister's compensation as a housing allowance by this date in order for ministers who own or rent their homes to receive the full benefit of a housing allowance exclusion for calendar year 2021. The designation should be adopted during a regular or special meeting of the church board, and should be contained in the written minutes of the meeting.
- Churches should designate a parsonage allowance for any minister who lives in a parsonage and who is expected to pay some of the expenses of maintaining the parsonage (e.g., utilities, furnishings, repairs, improvements, yard care).
- Donors must deliver checks on or by this date in order to claim a charitable contribution

deduction for 2020. Checks that are placed in the church offering during the first worship service in 2021 will not qualify for a charitable contribution deduction in 2020, even if the check is predated to 2020 or was actually written in 2020. However, checks that are written, mailed, and postmarked in 2020 will be deductible in 2020 even though they are not received by a church until 2021.

- An employee's marital status on this date determines his or her filing status for the year.
- If you have a minister or lay worker who is treated as self-employed for federal income tax reporting purposes, but who you would like to reclassify as an employee, the ideal time to make the change is on January 1, 2021.

#### Tax Filing Information

Your contribution information for 2020 will be enclosed in the January Informer. Please pay close attention and remove the contribution statement and put it with your tax filing information. Each year we get numerous request on April 14th saying they never received any information. We want to save you some stress. It will be in your January Informer.

IF you have a church or ministry, remember that you are required by law to get **contribution information** to your donors in a timely manner. **February 1, 2021** is the last mailing date for contribution statements to be sent to your donors.

Also remember only checks received by December 31, 2020 can be counted as 2020 deductions. The check may be hand delivered to the church or ministry on December 31, 2020 and count for that year or it can have a December 31, 2020 post mark on the envelope to count toward 2020 deductions.

## CHARTER RENEWAL DEADLINE MARCH 28TH

Charters under the PCAI Group 501(c)(3) Group Exemption will receive their Charter Renewal Yearly Report Packet in January.

Forms are also available on our website. www.paragonchristianalliance.org under "Resources" tab in a PDF file.

It is important that your report be received in our office no later than March 28th.

These renewals are <u>necessary</u> to <u>remain in</u> <u>compliance</u> with the IRS code and maintain your charter's tax-exempt status under the PCAI Group Exemption.

PLEASE REVIEW: This is a good time to review your monthly giving obligation to ensure you are up-to-date on your ministerial and charter giving. These must be current in order for your 501(c)(3) to be renewed in 2021.

## Church Tax/ Law Dates

If your church or organization reported withheld taxes of \$50,000 or less during the most recent lookback period (for 2020 the lookback period is July 1, 2018, through June 30, 2019), then withheld payroll taxes are deposited monthly. Monthly deposits are due by the 15th day of the following month.

Note, however, that if withheld taxes are less than \$2,500 at the end of any calendar quarter (March 31, June 30, September 30, or December 31), the church need not deposit the taxes. Instead, it can pay the total withheld taxes directly to the IRS with its quarterly Form 941. Withheld taxes include federal income taxes withheld from employee wages, the employee's share of Social Security and Medicare taxes, and the employer's share of Social Security and Medicare taxes.

## **Be Cautious with Designated Contribution...**

Building funds are every church's friend, right? While fundraising campaigns for specific ministries of the church can be a very useful tool to increase donations and giving, every ministry must be aware of the legal issues with accepting funds specifically earmarked for a single purpose.

If you accept designated funds, then be aware – you must use those funds only for the purpose for which they were designated. There have been numerous lawsuits regarding ministries that eventually, for a myriad of reasons, abandoned the plans for the original fundraising campaign but kept the raised funds. And in multiple cases, courts have ruled those funds must be returned to the donors.

# Year-End Checklist for Ministry Bookkeepers

- **1. Housing Allowance.** Church Boards and/or Congregations should designate an annual 2021 housing allowance for ministers who own or rent their home (and for ministers who live in a parsonage and pay some of their housing expenses).
- **2. W-4 forms.** All employees should complete new W-4 forms to ensure accurate withholding.
- **3. Notice of donors.** Donors should be advised in a church bulletin, newsletter, or by letter from the church, not to file their federal income tax return before they receive their Contributions Statement from the church. Some people may not be able to deduct certain contributions if they file a tax return before receiving their church contributions receipt.
- **4. Christmas gifts.** Be sure to correctly handle Christmas gifts made by the church or congregation to a minister or staff member. In most cases, these gifts represent taxable income and must be reported as income on the recipient's W-2 or 1099.
- **5.** Handling end of year contributions. The general rule is that a contribution is effective when delivered. This means that a check deposited in the church offering in January of 2021 becomes effective that day even if it is backdated to 2020. It is not deductible for 2020. One exception: Checks postmarked in 2020 are deductible in 2020 even though not received until 2021.
- **6. Business Expenses.** If your church reimburses some or all of a minister's business expenses, reimburse these year-end business expenses NOW.
- **7. Reclassification of workers.** Now is the time to decide if you want to reclassify any of your workers for tax reporting purposes. If you have a minister or lay worker who is treated as self-employed for federal income tax reporting purposes, and you would like to reclassify the person as an employee, the ideal time to make the change is on January 1st of the new year.
- **8. Voluntary withholding.** Ministers' wages are exempt from tax withholding. This means they use the quarterly estimated tax procedure to prepay their federal taxes. Ministers who report their income taxes as employees can enter into a voluntary withholding arrangement with their employing church. Under such an arrangement, the employing church withholds income taxes as it would for any other employee; and it can also withhold an additional amount of income taxes to cover the ministers' self-employment tax liability.
- **9. Order tax publications and renew subscriptions.** December is a good time to order your new 2021 copy of IRS Circular E (withholding table) and copies of Forms W-2, W-3, 1099, and 1096 that you will be issuing for compensation in year 2021. To order forms simply call the IRS toll-free number at 1-800-TAX-FORM (1-800-829-3676) or visit the IRS website (www.IRS.gov).
