> illustration Jesus is introducing Himself to the Jewish community. Through this, His first recorded sermon, He declares His authority—witnessed by the people to be greater than that of the religious teachers (Matthew 7:29).

#### Psalm 5:3

*"My voice you shall hear in the morning,* O Lord; in the morning I will direct it to You and I will look up."

"Now in the morning, having risen a long while before daylight, He went out and departed to a solitary place; and there He prayed" (Mark 1:35). This verse talks about Jesus' devotional time. Do you have your devotion before you start your activities and errands? What kind of morning devotion do you have in your life? Having morning devotion, a time with the Lord is important because it helps to surrender the day to the Lord and submit to the Lordship of Jesus Christ.

### History of the US Supreme Court

Excerpt from Christian Law Association

The importance and the need for an impartial judicial branch was understood all the way back to our Founding Fathers.

Every American understands the gravity and importance that a decision from the Supreme Court can bring, but how much do you know about this vital branch of the government's history? The importance and the need for an impartial judicial branch was understood all the way back to our Founding Fathers.

Article III of the Constitution sets forth the Supreme Court and the entire Judicial Branch, stating that:

The judicial Power of the United States, shall be vested in one Supreme Court, and in such inferior Courts as the Congress may from time to time ordain and establish. The Judges, both of the supreme and inferior Courts, shall hold their Offices during good Behavior and shall at stated Times, receive for their Services a compensation, which shall not be diminished during their Continuance in Office.

There are several very important things to note in this language. While the precise number of justices on the Supreme Court isn't listed (a power therefore implicitly given to Congress to decide per the first sentence), the importance of the Judicial Branch to be able to rise above partisan politics and bickering absolutely is addressed. The paragraph notes that the tenure of a judge shall be "during good Behavior" which has essentially meant life terms. This was a very deliberate choice to ensure that the law of the land would be long lasting and not dramatically change direction like a flag in the wind every time a different political party gained power.

Secondly, the Constitution specifically notes the salary of the Justices cannot be lessened during their terms in Office. This language was explicitly added to limit the power of the other two branches to exert undue influence over the Supreme Court Justices.

Congress initially decided the number of justices based on the number of federal circuit courts that the justices would oversee. The initial number of justices set by Congress was six. Interestingly, the court was so uniformed at that point the fact that six justices could create a stalemate was barely noticed. The total number of justices changed six times before settling on the current total of nine all the way back to 1869. The number of Supreme Court justices hasn't changed in over 150 years. The only attempt since 1869 was a partisan and illfated attempt by President Franklin D. Roosevelt in 1937.

President Roosevelt had just introduced the controversial and immense "New Deal" program, where he pushed through numerous pieces of legislation. The resulting

### Conscience Protection Act Excerpt from Christian Law Association

The Conscience Protection Act is a federal bill intended to protect the conscience of healthcare workers, including health insurance plans, from government discrimination if they decline to participate in abortions. It was originally introduced in 2019 and was recently reintroduced in 2021 by Senator Lankford and joined by many other Senators.

The Church Amendment of 1973 prohibits the coercion of those with religious and moral objections from being forced to participate in abortions by providing that hospitals and individuals who receive federal funding will not be required to participate in abortion. Even though federal law provides these protections, some states receiving federal funding are violating the law and healthcare workers who do not want to participate in the abortion need help.

Because these workers are left without a remedy or a way to get relief from being forced to participate in abortions when it is against their sincerely held religious beliefs, the Conscience Protection Act was introduced provide to healthcare professionals a stated and reasonable legal remedy to defend their freedom of conscience when infringed upon. This bill would allow healthcare workers not to have to choose between their jobs and participating in an act that goes against their religious beliefs.□

legal challenges to these proposed laws were substantial, and over the next year or so the Supreme Court struck down more pieces of legislation than at just about any other point in their history. This angered President Roosevelt, who felt that the Supreme Court was stopping him from enacting his "agenda". Sound familiar??

In response to his laws being stuck down, President Roosevelt floated a "Judicial Procedures Reform Bill" that would require justices to retire by age 70, and if they refused, allow the sitting President to immediately add a justice. Based on the makeup of the court at that time, it would have effectively allowed President Roosevelt to immediately add six new judges to the court.

The opposition to President Roosevelt's plan was immediate and intense from both sides of the political aisle.

The Chief Justice of the Supreme Court at the time, Charles Evan Hughes, came out against the plan, as well as a more liberal justice Louis Brandeis. The plan was lambasted by the public as well, with multiple political cartoonists at the time making comics about Roosevelt "packing the Court". The Senate rejected Roosevelt's efforts.

Now, more than seventy years later, the idea of "packing the Court" has returned to the public eye. Our very Constitution designed the Judicial Branch to not be a partisan mouthpiece, but an independent judiciary capable of upholding Constitutional values regardless of what the other two branches wanted to accomplish. Let's pray that the Supreme Court can survive these new attacks on its independence.  $\Box$
