# **GRACE IN ITS PUREST FORM**

Returning to find the Galatians again under the Law [of bondage], Paul (who had previously taught them about grace) exclaimed, "O you foolish Galatians, who has bewitched [that is. *mesmerized*—or deluded you, and caused you to follow [again] the Law [by casting a spell over you? Gal. 3:1]" They had once again reverted to arguing about holy days, holy foods, holy clothing, holy living, and holy swearing. Though much may be said today about "holy living" (which is pleasing to God); legalism is of little value, and puts people under bondage and slavery. People don't *need* to perform "good deeds" to be saved, but they will perform "good deeds" when they are saved.

The Bible says, ..."where the Spirit of the Lord is, there is

<u>liberty</u>; that is, freedom and not bondage" (2 Corinthians 3:17). That scripture applies to what I am saying because this freedom of the Spirit calls us into liberty from the law and away from the bondage of sin.

Too often people see grace as being a cover up for sin. But in truth the liberty we receive from the Spirit shows us grace is the power to walk away from sin. The law puts us under condemnation always showing us how weak we are and that we can never be free from the weight (the law) of sin. While grace shows us how strong God is and how willing HE is to intervene in our lives. This type of grace is received by faith. It is not a work of our wills.

In conclusion, I am convinced the Bible teaches

that *grace* is simply trusting in God's *love* to run the race of faith. Even though we may fall away and hurt ourselves and others, confession through and obedience to His word, we are given another chance. This is GRACE in its purest form! You may feel like a loser when you fall away, but a real winner will rise to the occasion and try... try... try again in the power of His grace.♥

#### NARRATIVE OF EIGHT DANGEROUS PEOPLE IN ANY ORGANIZATION


Below are eight groups of dangerous people that we need to know about and handle them with wisdom and knowledge but not to hate them.

## Social Media and the Church

#### Excerpt from Christian Law Association

Anyone can be recorded and posted to the internet for almost anything these days, and this is especially true of pastors and those in ministry. Recordings can be taken out of context and used as a tool to accomplish a devious purpose. We are concerned about pastors preaching the truth of the Gospel and others alleging such teachings as hate speech. The Bible teaches that we are to let our speech be always with grace (Colossians 4:6), so consider the following guidelines to aid in being both gracious while also speaking truth:

- 1. Know that what you post on social media matters. Words and ideas have consequences. Consider what you are posting what ramifications potential there may be due to the post. Ask yourself whether this the most gracious and loving way to communicate the Gospel. Ask yourself if what you are posting is rooted in the Gospel and coming from a humbled and confessed heart reliant on the Holy Spirit.
  - \*Are you reposting copy righted materials?

\*Are you posting confidential information or sensitive information? Consider the lawsuit of a Syrian Muslim convert to Christianity. His church publicly posted about his baptism and when he returned to Syria to visit family he was tortured and nearly killed due to his family learning of the baptism from the church's public post

on the internet. Oklahoma's

- Supreme Court found in favor of the man when he sued the church for the wrongdoing.
- \*Are you posting content on social media in violation of your employment agreement with your employer? Bivocational pastors and parishioners should ensure that it permissible is according to their employer to state in their profile where they work. We have corporations seen fire employees for unknowingly stating where they work in their social media profile and stating something on social media that was disapproved of by the corporation.
- 2. **Privacy settings don't** mean content will remain private. While social media platforms Twitter like and Facebook have privacy settings where one can restrict who has access to content, don't rely on such settings to protect People can take vou. screenshots and use other methods to share

"private" content. Do not post what you do not want others to see.

- 3. Actively participate in social media to control the narrative about you and your ministry. Make sure that you tell the world about yourself vour ministry and instead of finding yourself in a place where you are only responding to negative post or a clip taken out of context. Anyone coming to your social media site should be able to ascertain your ministry's purpose, intentions, and ethos. In addition to posting about who you are and what you believe, actively engage with those commenting on posts. Actively monitor posts so that you can proactively respond to any negative comments that or posts have potential to stir up Leverage problems. social media for positive good in your church community so that it is a positive tool for spreading the Gospel and loving others.
- 4. You're not guaranteed free speech on social media platforms. Free speech is a right from the government between the government and its

citizens. Face book does not guarantee free speech (unless you work for the government and that free speech is only in limited circumstances.) Do not expect all of your speech to be permitted in all contexts without consequences.

Churches should also have a social media policy in place that communicates to employees that what they say on social media matters and provides restrictions about what is permissible and impermissible.

Communicate with your employees that how you say something is often a huge component in how it is interpreted.

5. Let prayer and the Holy Spirit be your Commit your guide. ways to the Lord and ask the Holy Spirit to lead you in your public and forward-facing ministry. In faith, have confidence in the Lord to lead those you love to serve your church and serve your community. Walk in the Spirit when you post and engage in social media platforms. Ask for God's grace and wisdom as you share the Good News and rest in His goodness and strength as you carry on His purposes.

error and find yourself in an awkward situation, they will tell everyone of your weaknesses and expose you to ridicules. (Gen. 9:20-24)

#### Absalom Group

They are very close to you. They are impatiently ambitious. They detest your rising profile. They secretly position themselves to hijack and cut off those who believe in you and win them over by saying that they are better than you. They say all things about you, as being unfair, insensitive, wicked and incompetent. (2 Sam. 15:1-6)

#### Gehazi Group

They are excessively greedy and insatiable. They collect money behind your back. They ask for financial assistance and make people feel you are not taking good care of them. (2 Kings 5:20-24)

#### **Diotrephes Group**

This is the most dangerous group. They have a voice and influence among the people. They can come up with fabricated stories that could destroy your image and position. They are highly territorial. They are the false accusers and forgers of lies. (3 John 1: 9-10) Remember, these groups of people are found everywhere: In Families, among Friends, Businesses, Offices, Work place and Churches.

### **ANNOUNCEMENT: Church/Ministry Tax Date to Remember**

#### Monthly requirements

If your church or organization reported withheld taxes of \$50,000 or less during the most recent lookback period (for 2022 the lookback period is July 1, 2020, through June 30, 2021), then withheld payroll taxes are deposited monthly.

Monthly deposits are due by the 15th day of the following month. Note, however, that if withheld taxes are *less than \$2,500* at the end of any calendar quarter (March 31, June 30, September 30, or December 31), the church or organization need not deposit the taxes.

Instead, it can pay the total withheld taxes directly to the IRS with its quarterly Form 941. Withheld taxes include federal income taxes withheld from employee wages, the employee's share of Social Security and Medicare taxes (7.65 percent of wages), and the employer's share of Social Security and Medicare taxes (an additional 7.65 percent of employee wages).

#### May 16, 2022: File forms 990, 990-T, and 5578 Information return—Form 990

An annual information return (Form 990) for

tax-exempt organizations is due by this date for tax year 2021. Form 990 summarizes revenue, expenses, and services rendered. Organizations exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code must report additional information on Schedule A.

**Note.** Churches, conventions and associations of churches, "integrated auxiliaries" of churches, and church-affiliated elementary and secondary schools are among the organizations that are exempt from this reporting requirement. Organizations not exempt from this reporting requirement must file the Form 990 if they normally have annual gross receipts of \$50,000 or more.
