- 6. Provide three character references which affirm and endorse a life of integrity and attest that you strive to live a Christian life.
- 7. Be interviewed by the PCAI Credential Committee, which will then recommend to the Board of Directors approval for License or Ordination.
- 8. Support PCAI by giving a one-time application fee, annual renewal fee and monthly love offerings. (see page #4)

NOTE: Due to legal and insurance constraints, PCAI is unable to accept applications for membership from incarcerated applicants (prison inmates)

CREDENTIAL RENEWAL:

Membership is renewed annually on October 1st of each year. Ministers receiving membership within a particular year, there renewal will be the following year on October 1st. There is a \$50.00 renewal fee for Licensed and \$75.00 for Ordained Minister. Exempt Renewal Fee, see NOTE below.

FINANCIAL OBLIGATION: To provide a solid base of support and maintain the ability to operate as a solvent fellowship/ministry, thus enabling PCAI to reach out to the body of Christ around the world with the tools needed for effective ministry, Licensed Ministers are required to financially support the PCAI with a monthly love offering of \$35.00 minimum and Ordained Ministers \$45.00 per month minimum.

NOTE:

If ministers tithe to the fellowship, which is more than the minimum monthly giving, there is no renewal fee. (Proof of income must be submitted)

ATTENTION: However, an Ordained Minister who has been extended the **benefit of tax exemption for their ministry** "(**501** (c)(3)" under our "**group exemption**" (Paragon Christian Alliance Int'l, Inc.) shall give half (1/2) of their personal tithes in addition to the ministry charter fee. (Charter fee normally begins at \$35.00 a month to maintain your charter.)
